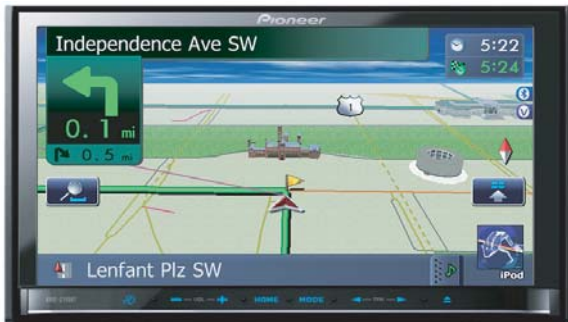




Happy Navi-Days Navigation Mail-In Rebate
